### A Message from the President

Hello and Happy Spring to everyone in our Fox Lake community. I hope you all had a good winter, or at least as good as the coronavirus pandemic would allow. Fortunately, our winter weather was not very severe this year and the ice left the lake earlier than usual.

As we move into summer, it remains unclear how pandemic restrictions will impact our FLA summer activities. The provincial steps of reopening determine what kinds of outdoor social gatherings we can have and how many people can attend and we cannot predict the dates that these regulations will take effect nor when they might need to be reversed. ### PLANNING AHEAD-SUMMER 2021 EVENTS

Please put the following dates in your summer calendar. As uncertainty continues with respect to public gatherings due to the pandemic, the FLA will still try to put some fun into our summer and we are trying to adapt to the new rules as best we can.

• FLA Annual General Meeting - Saturday July 10th at 10am. Limited in person attendance at Alix Yule's (422 East Fox Lake Road) as per Provincial Reopening Guidelines (anticipated to be a maximum of 25 people outdoors-RSVP required), plus virtual attendance via Zoom. The Zoom link will be e-mailed along with the meeting agenda and ways to RSVP a week in advance of the meeting.

- Fox Lake Regatta Saturday July 31. This year, we will be replacing our traditional Regatta format with a format that will feature some smaller events that can be done safely! As last year, we anticipate the sandcastle competition and other activities for kids will be on your own beach/shoreline including prizes for evidence or artwork of the Fox Lake Monster! We are tentatively planning to hold a safe horseshoe competition (players only, no spectators) and some canoe races or boating events. Details coming soon.
- Fox Lake Corn Roast and Fall Fair Saturday September 4. We are going to decide on if, and in what format, we can hold this event by early August. We will send out details as soon as we know what they are!

# **LAKE STEWARD REPORT**

Ice-On occurred on December 16, 2020. The lake was frozen for 113 days until Ice-Off on April 8, 2021. This was the fourth shortest period of ice cover on record.

Water samples were submitted to the Ministry of the Environment Conservation and Parks this spring, so we should have results for Phosphorus and Calcium for 2021. We are expecting to conduct Benthic Monitoring on Friday August 20. The exact protocols are yet to be finalized by the District of Muskoka due to changing COVID-19 restrictions. More details will be provided when available.

The following paragraphs, from last fall's newsletter, are worth a re-read after the concerning algae occurrence last September.

"One significant development this year were reports of unusual algae blooms. Apparently, this has been an issue throughout the Muskoka region this summer.

In September a report of a bloom on the west side of the lake was investigated by the FLA and reported to the Ministry of the Environment Conservation & Parks (MECP). MECP was to come and investigate, however with no access to a public boat launch (they are prohibited from using private craft) and the passage of time, the obvious bloom had dispersed and could not be sampled.

Algae naturally occur in ponds, rivers and lakes and are the base of the food web. Algal blooms typically occur in the late summer and fall in shallow, slow moving and warmer water. A "bloom" is when a population of algae increases rapidly. One of the suspected triggers for these events is high levels of nutrients, like nitrogen and phosphorus. Recommended actions to minimize the risk of blooms include ensuring septic systems function properly, maintaining/planting shoreline vegetation to reduce runoff, and minimizing lakeside lawns and fertilization."

If you do see an unusual algal bloom, please be cautious to avoid exposure, report it to the Spills Action Centre at 1-866-663-8477 and the Fox Lake Association. The Ministry will provide the FLA with sampling equipment and perform the subsequent analysis.

# **COTTAGE RENTALS IN 2021**

There are two provisions within the Ontario Emergency order that affect cottage rentals in Huntsville/Fox Lake right now:

- 1. The **short-term rental ban** continues as part of the Ontario Emergency Orders that have been extended until at least June 2. That means that no short-term rentals are allowed except in cases where emergency accommodation is required. Short-term rentals are permitted once Ontario moves into Step 1.
- 2. Social gatherings: outdoor only for less than 10 people until Ontario reaches Step 2 (early July).

The OPP is responsible for enforcing these Covid-19 related emergency orders and can be contacted at 1-888-310-1122

Separately, as part of a public consultation process that began in early 2019, the Town of Huntsville has enacted bylaw 2019-122, which is an act to **regulate short-term rentals** in our area. This by-law has a significant impact on the rental of cottages in our area.

Some of the key provisions include:

- a. **All rental properties must be licensed** with the town. Licensing includes requirements such as a site plan be submitted for the property and the property will be inspected to ensure it meets all current fire and safety codes.
- b. An annual fee must be paid to the town to operate the rental;
- c. Limits on the number of people and cars are mandated as part of the license, including **occupancy limited to two (2) people per legal bedroom**, and cars limited based on the amount of legal parking space available.

### **DARK SKIES**

Both Fox Lake Association and the Town of Huntsville's Plan encourages landowners to help Stop Light Pollution in Our Night Skies.

FOCA points out that there are many benefits to "Dark Night Skies". They list and elaborate on the following:

# WHY we should care:

- Star gazing is an amazing family activity:
- Better nighttime with less nuisance glare
- Increased safety on both land and water. Light pollution from unshielded, broad range lights near lakes is made worse by the reflection off water.
- Energy and Monetary savings
- Protection of wildlife and lake ecosystems. Light plays myriad roles in nature: changing light patterns can disrupt an ecosystem's balance. In water environments, daily cycles for organisms such as zooplankton are controlled by light, while others, such as fish, are attracted or repelled by it. Studies show that moths, fireflies, salamanders, frogs, songbirds and other wildlife are affected when artificial nighttime lighting influences navigation, predator-prey relationships, foraging behaviour, reproduction, mating, and other biological and ecological characteristics.

**HOW we can help** - landowners are encouraged to prevent light pollution by:

- When shopping for lights ask questions and seek out lights that reduce light pollution.
- Light for necessity only
- Choose glare-free lights and lights that are shielded to direct light down on targeted areas and stop light from escaping sideways and upwards.
- Aim lights down and away from water. Choose lights that direct light onto the ground, where it is needed.
- Install lower wattage bulbs
- Use dimmers and timers

Not sure about the light spillage from your property? Go out after dark and observe them from the water or ask a neighbour to provide feedback.

# **NOISE AND FIREWORKS**

Noise travels much farther over water than it does over land. Noise from equipment, barking dogs and sound systems can be disturbing, especially to those across the water. Please ensure that your sound system speakers are facing away from the water and the volume kept to a level that you can enjoy but your neighbours can't hear. The Huntsville Town Noise By-law prohibits most loud noise between 9:00 p.m. and 7:00 a.m. and loud music between 11:00 p.m. and 7:00 a.m.

The Town Fireworks By-law allows fireworks to be set off only on weekend evenings (Friday, Saturday and Sunday) between 6:00 and 11:00 p.m. and on Victoria Day, Canada Day, Labour Day and New Year's Eve between 8:00 and 11:00 p.m. Fireworks are not allowed at all when the fire hazard rating is severe and outdoor fires are also banned.

# **GARBAGE AND RECYCLING**

Garbage/recycling pickup is weekly May to the end of October. November to the end of April pickup is biweekly for garbage and weekly for recycling. With pickup on Tuesdays for West Fox Lake Road and Thursdays for East Fox Lake and North Fox Lake Roads, garbage left by weekend visitors may sit outside for several days awaiting pickup. Animals of the woods and birds of the air can make a mess of garbage and recycling left outside unless it is in proper containers. Plastic bags and open recycling boxes are temptations for birds, in particular ravens, and four legged creatures. Please ensure your garbage is in an animal proof bin and your recycling covered. Suggestions for recycling - make sure recycled containers are clean and left in clear bags (required) or blue bins that are covered by a blanket or tarp or placed in a specific covered container designated for recycling. If this is not possible, please take recycling home with you.

**Recycling Requirements** - Muskoka continues to have a two-stream recycling program with paper products separated from plastics, cans, glass and aluminum. Cardboard boxes need to be broken down, flattened and tied together. Find the list of what can be recycled here below and note it may not be the same as other municipalities where you recycle. For example, Muskoka DOES recycle coffee cups (paper) and dark plastic coffee cup lids (plastics) and black plastic

Large items such as barbecues, chairs, broken tables, mattresses will not be picked up and must be taken to the Stisted or Bracebridge landfill site for proper disposal by the property owner. Hazardous waste disposal is available at the Bracebridge site and on specific days at the Madill transfer station. Electronic waste can be dropped off free of charge at All Ontario Recycling (Port Sydney), Bracebridge landfill site or McIntyre Electronic Recycling, 7 East Airport Rd. Huntsville.(9-5 M-F, 9-12 Sat) Bins are available for 24/7 drop-off.

We trust that this information is helpful in ensuring our Fox Lake roadways remain free of garbage litter.

Does it swim and lunge or does it have land legs and is able to creep onto our beaches?


What does it eat? Is that why all the bull frogs have disappeared?
